Applications and payment in full (either by check or credit card) are due no later than April 1, 2022.

All portions of the vendor application must be complete, including a photo of your booth or truck and payment in full, to be considered for acceptance into the 2022 Teton County Fair.

All food vendors must additionally complete the "Temporary Food Service Application" and file it with Teton County Environmental Health, along with their \$25 temporary food vendor application fee.

Mail "Temporary Food Service Application" and \$25 fee to: Teton County Environmental Health, PO Box 937, Jackson, WY 83001 no later than 14 days prior to Fair (July 13, 2022). Do not send this to the Fair Office.

Vendors MUST bring their own tents, tables, and chairs; the Teton County Fair Board will not provide any of these items.

There is no camping available on the fairgrounds; all vendors are responsible for making their own accommodations.
